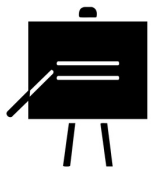

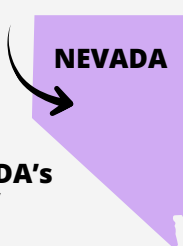

Our work as both trial counsel and amicus on appeal led to the Maryland Supreme Court overturning our client's 30-year sentence, and became the first court decision to recognize that self-managed abortion with pills is safe, effective, and normal in **MARYLAND**

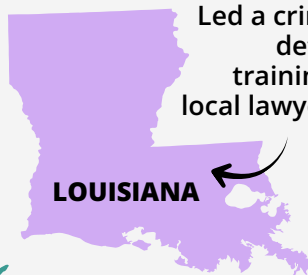

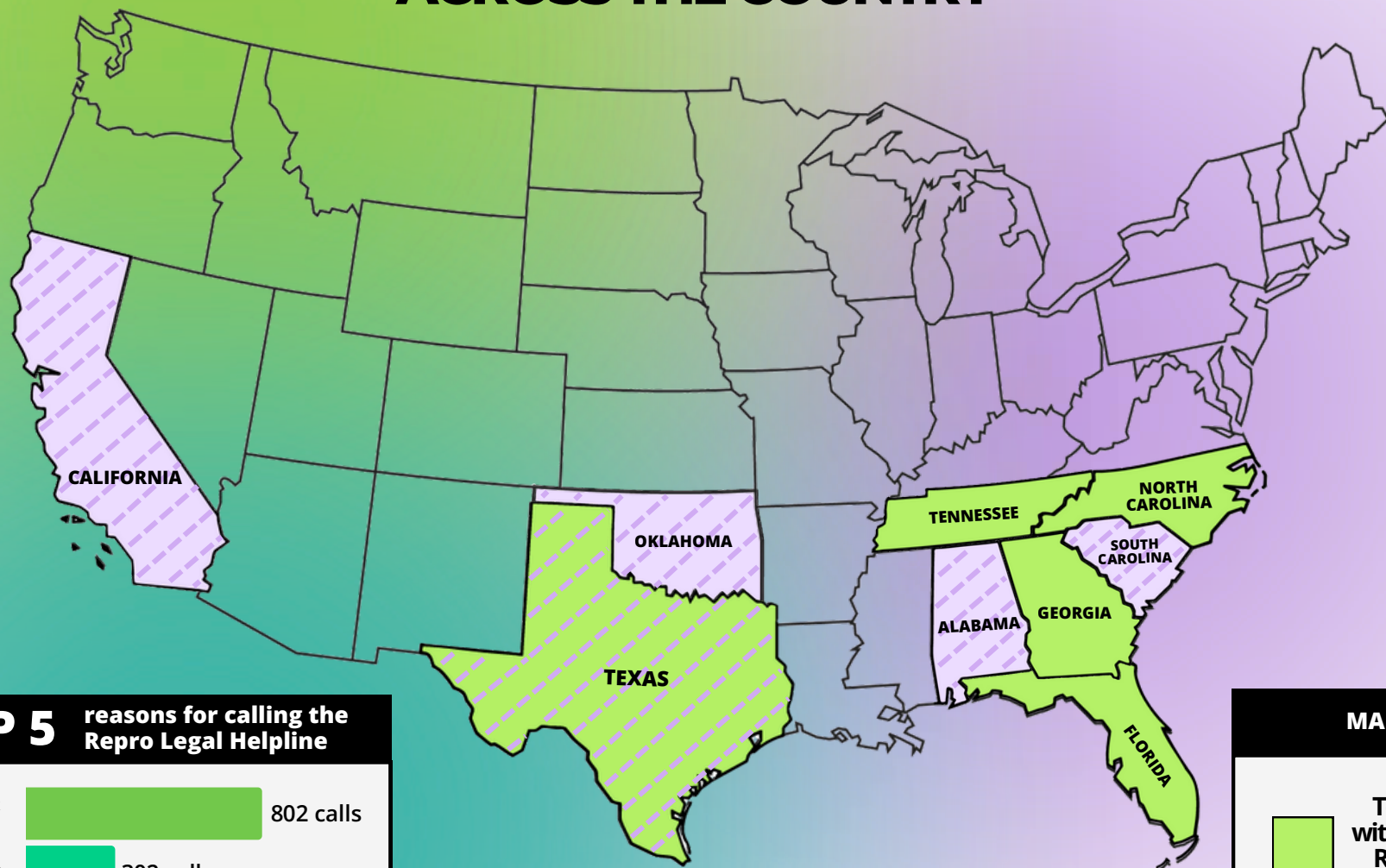

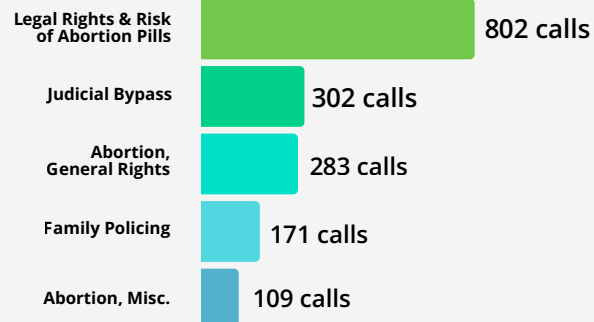
